### Lock In Rules:

- 1. ALL PARTICIPANTS MUST REGISTER! Make sure you reserve your spot online or by calling 515-278-3945**
- 2. Only teens ages 12-17 may attend this lock-in. Sorry, no exceptions.**
3. Stay with the group. An adult must know where you are at all times.
4. Stay inside and in bounds. An adult will explain which areas are off-limits.
5. Keep it kind! Keep your hands, feet, and any unkind thoughts to yourself.
6. No one may leave the building until the lock-in is over.

I agree to follow all these rules and any instructions an adult gives me at the lock-in. I understand that if I break the rules, my parents may be asked to pick me up early.
